- (a) The holder of the following office shall be a foundation governor ex-officio: Principal Officiating Ministers at St Mary, Great Shelford and All Saints', Little Shelford (2).
 - (b) The Archdeacon of the Archdeaconry in which the school is situated shall be entitled to appoint a foundation governor to act in the place of the ex-officio foundation governor whose governorship derives from the office named in (a) above, in the event that the ex-officio foundation governor is unable or unwilling to act as a foundation governor, or has been removed from office under regulation 21(1) of the Regulations.
